C. Watershed Technician—See Attached

- a. In the last month I have been motivated to get more County Cost Share Applications, and I have a few producers interested to know more when seeding is finished. I want to do more outreach and get more people interested in small grants, so I am going to try and make that a goal for next meeting. Also, I have been continuing my goal of getting my Planners Certification by continuing to go to trainings and trying to get more JAA.
- b. For our County Cost Share program, in the last month I have been doing a lot of out-reach and contacting producers that have mentioned wanting to do CCS and setting up field visits. I have looked at Stock Water and Cross Fencing with Amanda to certify, I alone have looked at three possible Cross Fencing applications, two being in the John Day side and one in the Deschutes side and I went out with Amanda and Nick to look at where the BDA's will be implemented, and we looked at what materials would be best used.
- c. I am currently filling out an SIA small grant application for a second phase of fencing. The application is due on the 24th of October, and I should hopefully have it submitted by next week
- d. For NRCS I went out into the field with Becky to do an initial Stock Water visit to learn how to plan the practice and looked at CRP. Misty has also told me that I will be helping with EQUIP.
- e. With education outreach, I was able to help for a few days with the Poster contest. And I will be going to the school with Marylou on Wednesday and Thursday this week to help her talk about STEP with the kids.
- f. I also just finished a three-day virtual training that covers soil health, this is a training that was for advanced and new planners. We learned about different practices for soil heath, we came up with different scenarios to create management plans and present them. There is going to be a field training in Redmond to learn and perform soil tests later this month.

g. Coming up on my calendar for October, the OACD conference with Marylou and Amanda in Hood River is coming up on the 15th and 16th. The second part of my soils training Oct. 22- 24th, in Redmond, OR. Lastly, I have a Cons Plan Business Tool Training that is virtual Oct. 29-31st.
